#### **Opening comments**

Motion by Krysta Austen, seconded by Tom Brown, to post position for PT Food Service Coordinator/School Chef for \$13/14 per hour. All in favor, none opposed. Motion carried.

#### **Facilities Committee**

Plan First contract recommendation presented.

Motion made by Tom Brown, seconded by Elaine Sturges, to approve the Plan First contract as presented. All in favor, none opposed. Motion carried.

Building Response Team (BRT) for SAVE plan: Sara Petit-McClure will serve as Team Leader, Krysta Austen will fill Board Member Role, and Chris Austen will fill Law Enforcement Role. They will build the

team including a parent representative and local community member.

The committee recommended keeping the current Frontier Phone Line & Internet Connection configuration to have a redundant Internet Connection.
